Mr. GARAMENDI (for himself and Mr. THOMPSON of California) introduced the following bill; which was referred to the Committee on Natural Resources

A BILL

To modify the boundary of the Berryessa Snow Mountain National Monument to include certain Federal land in Lake County, California, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Berryessa Snow Moun-
5 tain National Monument Expansion Act”.

6 **SEC. 2. DEFINITIONS.**

7 In this Act:

8 (1) WALKER RIDGE (MOLOK LUYUK) ADDI-
9 TION.—The term “Walker Ridge (Molok Luyuk) Ad-

1 dition” means the approximately 3,925 acres of Fed-
2 eral land administered by the Bureau of Land Man-
3 agement land in Lake County, California, and iden-
4 tified as “Proposed Walker Ridge (Molok Luyuk)
5 Addition” on the Map and all lands and interest in
6 lands therein and objects thereon.

7 (2) MAP.—The term “Map” means the map en-
8 titled “Proposed Walker Ridge (Molok Luyuk) Addi-
9 tion Berryessa Snow Mountain National Monument”
10 and dated October 26, 2021.

11 (3) MOLOK LUYUK.—The term “Molok Luyuk”
12 means Condor Ridge (in the Patwin language).

13 (4) NATIONAL MONUMENT.—The term “Na-
14 tional Monument” means the Berryessa Snow Moun-
15 tain National Monument established by Presidential
16 Proclamation 9298 of July 10, 2015 (80 Fed. Reg.
17 41975 (July 15, 2015)), and all lands and interest
18 in lands therein and all objects thereon identified by
19 such Presidential Proclamation.

20 **SEC. 3. NATIONAL MONUMENT EXPANSION.**

21 (a) BOUNDARY MODIFICATION.—The boundary of
22 the National Monument is modified to include the Walker
23 Ridge (Molok Luyuk) Addition.

24 (b) MAP.—

1 (1) CORRECTIONS.—The Secretary of the Inte-
2 rior may make clerical and typographical corrections
3 to the Map. Such corrections shall have the same
4 force and effect as if the revised Map were included
5 as part of this Act.

6 (2) PUBLIC AVAILABILITY.—The Map, and any
7 subsequent revised Map, shall be publicly available
8 on the website of the Bureau of Land Management.

9 (c) ADMINISTRATION.—Subject to valid existing
10 rights, the Secretary of the Interior shall administer the
11 Walker Ridge (Molok Luyuk) Addition—

12 (1) as part of the National Monument;

13 (2) in accordance with Presidential Proclama-
14 tion 9298 of July 10, 2015 (80 Fed. Reg. 41975
15 (July 15, 2015)); and

16 (3) in accordance with applicable laws (includ-
17 ing regulations).

18 **SEC. 4. MANAGEMENT PLAN.**

19 (a) IN GENERAL.—Not later than 1 year after the
20 date of enactment of this Act, the Secretary of the Interior
21 and the Secretary of Agriculture shall jointly develop a
22 comprehensive management plan for the National Monu-
23 ment in accordance with, and in a manner that fulfills the
24 purposes specified in, Presidential Proclamation 9298 of
25 July 10, 2015 (80 Fed. Reg. 41975 (July 15, 2015)).

1 (b) TRIBAL CONSULTATION.—The Secretary of the
2 Interior and the Secretary of Agriculture shall consult
3 with affected federally recognized Indian Tribes—

4 (1) in the development of the management plan;

5 and

6 (2) to inform subsequent management decisions
7 regarding the National Monument.

8 (c) CONTINUED ENGAGEMENT WITH INDIAN
9 TRIBES.—The management plan shall set forth param-
10 eters for continued meaningful engagement with affected
11 federally recognized Indian Tribes in implementation of
12 the management plan.

13 **SEC. 5. AGREEMENTS AND PARTNERSHIPS.**

14 (a) IN GENERAL.—To the greatest extent practicable
15 and in accordance with applicable laws, the Secretary con-
16 cerned shall enter into agreements, contracts, and other
17 similarly cooperative and collaborative partnerships if re-
18 quested by an affected federally recognized Indian Tribe
19 regarding management of the National Monument pursu-
20 ant to relevant Federal authority, including—

21 (1) the Indian Self-Determination and Edu-
22 cation Assistance Act (25 U.S.C. 5301 et seq.);

23 (2) the Federal Land Policy and Management
24 Act of 1976 (43 U.S.C. 1701 et seq.);

1 (3) the Tribal Self-Governance Act of 1994 (25
2 U.S.C. 5361 et seq.);

3 (4) Executive Order 13175 (dated November 6,
4 2000);

5 (5) the Tribal Forest Protection Act of 2004
6 (25 U.S.C. 3115a et seq.);

7 (6) section 8206 (good neighbor authority) of
8 the Agricultural Act of 2014 (16 U.S.C. 2113a);

9 (7) Secretarial Order 3342, dated October 21,
10 2016; or

11 (8) Joint Secretarial Order 3403 (dated No-
12 vember 15, 2021).

13 (b) DEFINITION OF SECRETARY CONCERNED.—In
14 this section, the term “Secretary concerned” means, as
15 applicable—

16 (1) the Secretary of the Interior, acting through
17 the Director of the Bureau of Land Management; or

18 (2) the Secretary of Agriculture, acting through
19 the Chief of the Forest Service.

20 **SEC. 6. RENAMING OF WALKER RIDGE IN LAKE AND**
21 **COLUSA COUNTIES, CALIFORNIA.**

22 (a) IN GENERAL.—The parcel of Federal land admin-
23 istered by the Bureau of Land Management located in
24 Lake and Colusa Counties in the State of California and
25 commonly referred to as “Walker Ridge” before the date

1 of enactment of this Act shall be known and designated
2 as “Condor Ridge (Molok Luyuk)”.

3 (b) REFERENCES.—Any reference in a law, map, reg-
4 ulation, document, paper, or other record of the United
5 States to the parcel of Federal land described in sub-
6 section (a) shall be deemed to be a reference to “Condor
7 Ridge (Molok Luyuk)”.

8 (c) MAP AND LEGAL DESCRIPTION.—

9 (1) PREPARATION.—

10 (A) INITIAL MAP.—The Board on Geo-
11 graphic Names (established by section 2 of the
12 Act of July 25, 1947; 43 U.S.C. 364a) shall
13 prepare a map and legal description of the par-
14 cel of Federal land designated in subsection (a)
15 as Condor Ridge (Molok Luyuk).

16 (B) CORRECTIONS.—The Board on Geo-
17 graphic Names and the Director of the Bureau
18 of Land Management may make clerical and ty-
19 pographical corrections to the map and legal de-
20 scription prepared under this subsection.

21 (2) CONSULTATION.—In preparing the map and
22 legal description under paragraph (1)(A), the Board
23 on Geographic Names shall consult with—

24 (A) the Director of the Bureau of Land
25 Management; and

1 (B) affected federally recognized Indian
2 Tribes.

3 (3) PUBLIC AVAILABILITY.—The map and legal
4 description and any subsequent revised map or legal
5 description prepared pursuant to paragraph (1) shall
6 be publicly available on the website of the Board on
7 Geographic Names, the Bureau of Land Manage-
8 ment, or both.

9 (4) LEGAL EFFECT.—The map and legal de-
10 scription, and any subsequent revised map or legal
11 description prepared pursuant to paragraph (1) shall
12 have the same force and effect as if included in this
13 Act.
